CONTINUATION ORDER

WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely **Rayapati Venkatta Ranga Rao College of Education, JKL College Road, Pattachipuram Post, Guntur – 522006, Andhra Pradesh** vide order No. F.SRO/NCTE/2001-2002/7121 dated 20.07.2001 for conducting B.Ed. programme of one-year duration with an annual intake of 160 students from the academic session 2001-2002.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, a corrigendum was issued to the institution vide order no. F.SRO/NCTE/AOS00402/B.Ed./AP/2015/69161 dt. 02.07.2015 for grants recognition to **Rayapati Venkatta Ranga Rao College of Education, JKL College Road, Pattachipuram Post, Guntur – 522006, Andhra Pradesh** for conducting B.Ed. Programme of two years duration with an annual intake of 150 students (three basic units) from the academic session 2015-2016.

4. **AND WHEREAS**, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, a Show Cause Notice was issued on 09.09.2020.

5. **AND WHEREAS**, the SRC in its 412th meeting held on 05th – 06th July, 2022 considered the matter and decided to issue a last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 26.07.2022. The institution has submitted reply on 13.08.2022 & 18.08.2022.

6. **AND WHEREAS**, the SRC in its 413th Meeting held on 22nd – 23rd August, 2022 considered the matter and decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Rayapati Venkatta Ranga Rao College of Education, Survey No. 2, J.K.C. College Road, JKC Nagar Pattabhipuram Post, Guntur – 522006, Andhra Pradesh** for B.Ed. programme for **3 basic units of 50 students each.**

7. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Rayapati Venkatta Ranga Rao College of Education, Survey No. 2, J.K.C. College Road, JKC Nagar Pattabhipuram Post, Guntur – 522006, Andhra Pradesh** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **3 basic units of 50 students each** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
